## DESCRIPTION:

The office files of Harlan F. Stone (1872-1946), Dean of the Columbia University School of Law, 1910-1923. Most of the correspondence is with students, faculty members and lawyers throughout the country and deals with recommendations for positions, lectureships and appointments, alumni affairs, student affairs, the Columbia Law Review, the New York Bar Association and the Association of American Law Schools. There are also reports of school activities and notes and typescripts of Stone's lectures, as well as photographs. Harlan Stone's papers from the period of his service as Chief Justice of the U. S. Supreme Court, 1925-1946, are in the Library of Congress.
